Instructions on how to transfer your Ontario Savings Bonds:

If you are a holder (the "Transferor") and would like to transfer all or part of your Ontario Savings Bonds to someone else (the "Transferee"), complete the form below. Be sure to fill in the total principal amount of Ontario Savings Bonds that you would like to transfer. The Transferor(s) and Transferee(s) must sign the form below. Date the transfer form and send it together with the bond certificate(s), by registered mail, courier or hand delivery, to:

Please note that once a request is submitted, it cannot be cancelled. No transfers will be permitted on any Redemption Date, or during the 15 days immediately preceding.

NOTE TO TRANSFERORS ABOUT THE SIGNATURE GUARANTEE:

All transferor's signatures must be guaranteed by a Canadian Schedule 1 chartered bank or a major Canadian trust company whose signature guarantee is acceptable to the Province and the Registrar. The guarantor of the signature warrants that at the time of signing, the signature is genuine, the signer is the appropriate person to endorse, and the signer has legal capacity to sign. Original signatures are required, faxes or photocopies will not be accepted.
